## ALTERNATIVE WORSHIP SERVICE SITES May 31, 2017

Over the last eight months the Sunday Transition Team (STT) has reviewed each of the locations outlined below as a possible site for interim Sunday worship services. The STT has shared and discussed its findings with the Facilities Commission and the Vestry.

The STT kept in mind, at least these requirements, when evaluating each site.

- 1. Sunday morning primary worship time
- 2. Adequate seating to accommodate worship services.
- 3. Adequate area(s) for Sunday School classes.
- 4. Adequate parking (preferably on site).
- 5. Available for use for 109 consecutive Sundays over 24 months.
- 6. Convenience of site (distance from All Saints).
- 7. Adequate on site storage.
- 8. Cost.

Friendship Center Interior Open Space Area – Too disruptive to principal use of site.

Erecting a Tent on Campus – Would exceed 180 day maximum limitation permitted for a tent.

Vacant West State Street Church – Building razed for new residential development.

Vacant Commercial or Industrial Building – Parking and cost.

El Montecito Presbyterian Church – Presently holding Sunday services.

Montecito Covenant – Presently holding Sunday services.

Trinity Episcopal Church – Presently holding Sunday services.

Montecito Union – Not available during summer months.

Rincon Beach Club – Fully occupied during summer months.

Santa Barbara Woman's Club – Too many occupied weekend activities.

Tent Merchant Prop House – Not available for use.

Public Library – Not available for Sundays needed.

Santa Barbara City College Auditorium – Little, to no response.

Westmont College – Conditional Use Permit (CUP) limitations.

Biltmore Conference Center – No space available on holidays and cost.

Laguna Blanca – No space available.

Veteran's Memorial Building – Inadequate classroom space, no parking.

Crane School – Conditional Use Permit (CUP) limitations.

Buddhist Temple – Too small and inadequate parking.

Congregation B'nai B'rith – In use on Sundays.

Hindu Temple – In use on Sunday mornings.

Riviera Theater – Scheduled to close for renovation.

St. Anthony's Chapel – Not available.

Music Academy of the West – Conditional Use Permit (CUP) limitations.

Seventh Day Adventist – In use on Sundays.

New Vic – Lack of classroom availability.

Doubletree – Lack of classroom availability, over budget.

Santa Barbara Recreation Center Ball Room – Not available.

Cabrillo Arts Center – Scheduled to close for renovation.

Howard School – Inadequate space.

Pacifica Institute – No availability.

Museum of Natural History- No availability.

Casa de Maria – Too small and no availability.

Plaza Playhouse Theater – No classroom space available.
