Project Scope Reduction & Budget Status

Project History in Brief

- ▶ 2012 Confirmed Sanctuary was vulnerable
- Fundraising, architect, County approval
- Rebuilt Bell Tower in 2016
- Sanctuary construction was set for Fall 2017
 - Worship location questions
 - Parish School concerns
 - January 2018 Thomas Fire & Debris Flow

Project Scope Reduction

- June 2018: Construction bids come in above budget
- Immediate meetings with architect, engineers, general contractor bidders
- No parishwide fundraising; no long-term debt
- Reduce Project scope to bring in within funds available

Project Scope Reduction

- Letter of intent: Armstrong Associates
- Project goal: Seismic Stability
- Everything else was available to reduce/cut

Project Scope Reduction

- Roof work cut
- New addition (into Parish School yard) eliminated
- Concrete use a lot less everywhere
- Tracker organ requirements
- Move from tracker organ to digital

Major Budget Savings – Largest Categories

- Contractor's "General Conditions: ▼\$100,000
- Concrete: ▼\$400,000
- Carpentry: ▼\$400,000
- ▶ Heating/AC: ▼\$400,000
- Additional misc. categories = major cuts
- Bottom line (preliminary): Construction costs from \$7.2 million to \$5.2 million

#1: The Early Years

- ▶ 2013 Parish Survey
- 2014 Organ committee formed
- ▶ 2014 Designated gift of \$1.25 million
 - Considered several makers of fine organs
- ▶ 2016 Vestry approves Fisk contract
 - \$1.25 million total
 - 20% non-refundable deposit

#2: Where to Put the Organ

- Several months of debate
- Fisk pushed to locate at main entrance
 - Acoustical benefits
- Unworkable: architecturally, flow
- Fisk acceded, but . . .
 - Required several costly acoustical improvements

#3: Doing The Unthinkable

- Revisited the Tracker v. Digital organ
- Approached the organ donor
- Terminated the Fisk contract

Feasibility of a Digital Organ

- Nelson Huber is "thumbs up" on recent models
- Overcomes our acoustic deficit
- Interviewed vendors; cost approx. \$275,000
- Today's models appear very durable
- No need for acoustic enhancements, special HVAC or new larger basement

#3: Doing The Unthinkable

- Revisited the Tracker v. Digital organ
- Approached the organ donor
- Terminated the Fisk contract

Major Budget Savings = Saves the Project

Gift for purchase of new organ	\$1,250,000
Payments to Fisk	-\$266,000
Cost of digital organ	-\$275,000
FUNDS FREED UP	\$709,000

Next Steps: Organ

- Consult Organ Committee, outside experts
- Report from Music Director's research
- Select from two finalists a new digital organ

"Sojourn" Time in Parish Hall

- Single time for all Christian formation
 - Separate classes for children, youth, adults
- Lay leaders: volunteers, training
- Children, youth fully participate in worship

New Schedule

Schedule

- November/December 2018
 - Prepare new construction drawings
- January/February 2019
 - General Contractor re-bids project
- January 27, 2019 Last service in Sanctuary
 - Feb. 2/3 Begin worship in Parish Hall
- February/March 2019
 - Remove everything from inside Sanctuary
- April 2019
 - Begin construction; approx. 14 months
